

# Category 1 – Deemed Minor Trade Waste Customer Listing Schedule

All businesses or institutions that are classified as Category 1 Trade Waste must comply with the conditions contained in the default Trade Waste Consent (Appendix A). Customers defined as Category 1 Trade Waste are considered to have entered into a default Trade Waste Consent with Westernport Water.

Westernport Water may add or remove businesses or institutions from this schedule in light of further operational experience. Westernport Water may inspect premises to confirm that the actual business is Category 1 Trade Waste.

### All businesses or institutions other than those assessed as being Category 1 Trade Waste will be required to enter into a Trade Waste Agreement with Westernport Water.

### **Definition of Category 1 Deemed Minor Trade Waste**

Customers who, by definition in Water Law, discharge trade waste, but that discharge only small quantities of trade waste to Westernport Water's sewer and which is of a similar nature to domestic sewage will be defined as Category 1 Deemed Minor Trade Waste.

#### Listing Schedule

Food business classified under the Food Act 1984 as Class 4

Chemist / Pharmacy

Doctors Surgery or Dental or Veterinary Clinic (excluding those with automated x-ray machines or for Vets kennel wash down areas)

Florist

Hairdresser / Beautician

Accommodation Homes / Hotels / B&B (Less than 10 residents)

Opticians

Funeral Parlours

Sandwich and/or Coffee Shop – No hot food



# APPENDIX A

# DEFAULT CONSENT TO DISCHARGE MINOR TRADE WASTE

Westernport Water agrees to accept trade waste discharge from the customer subject to the following conditions:

# 1. Type of Discharge

- **1.1** The waste is of similar nature to domestic waste.
- **1.2** The customer shall notify Westernport Water immediately where it is proposed that the quality or quantity of the waste discharged to the sewer is to change.

## 2. Inspection and Monitoring

- 2.1 The customer shall allow Westernport Water access to the property at times when Westernport Water reasonably believes the customer is operating for the purposes of monitoring the quality and quantity of waste discharge to sewer.
- **2.2** Westernport Water may sample the waste from any place on the property, and test for any physical or chemical parameters.

## 3. General

- **3.1** The consent constitutes the entire consent between the parties. Any previous agreements, understandings and negotiations on the subject matter of this consent shall have no effect.
- **3.2** Any failure, delay or indulgence on the part of Westernport Water in exercising any power or right under this consent does not waive that power or right nor does any single exercise of power or right preclude any other or future exercise of that power or right. A power or right may only be waived by Westernport Water in writing.
- **3.3** Nothing in this consent detracts in any way from any power conferred on Westernport Water by law.
- **3.4** Amendment may be made by Westernport Water where allowed in the consent or by signed agreement of both parties in writing.
