

# Gas business opportunity San Remo

Westernport Water is seeking expressions of interest from qualified gas business experts for a business opportunity in San Remo on the Bass Coast.

This is a rare opportunity to acquire a gas business that supplies LPG to an established customer base via a reticulated network.

#### About the opportunity

Since 2006, Westernport Water has operated a gas retail business (Westernport Gas) which is a nonprescribed function of Victorian Water Corporations, under the Water Act 1989.

The gas business provides LPG gas to 54 domestic customers in the Bass Coast Resort apartments and surrounding houses in the San Remo area, via a reticulated network connected to a tank located on leased land at the Silverwater Resort.

Westernport Water is looking to transfer the existing reticulated service to another operator to enable a smooth transition for customers at equivalent or better rates.

The region is recognised as a unique place of environmental significance where quality of life and sense of community is balanced by sustainable development.

The existing storage supports the current customer base, however there is opportunity for further regional development and a rapidly growing residential community in the area.

## **Opportunity**

The current potential for business expansion is limited to the nearby Island View Estate development. WPW has successfully negotiated with the developer to provide reticulated gas services for Stage 1 to 3 which cover 88 lots and to provide gifted assets to WPW.
