- R3 Inspection Final inspection prior to key handover to property owner, Recycled Water meter stop lock will be removed if R3 inspection passes

*It is the plumbers responsibility to contact Westernport Water on 1300 720 711 to arrange for these inspections. Please refer to our website for current fee.

- Separate meters are to be used for the dual pipe system and installed within two working days of pick-up from depot.
- Any tapping excavation deeper than 1.5 metres MUST be timber shored or benched
- Bridging pipes are not acceptable and constitute water theft
- Pipes and fittings must meet Australian standards
- Recycled water meter assemblies and above ground pipes must be solid purple in colour

*Westernport Water requires that when an application is made to connect to our water services, the applicant must also connect to the recycled water when the property is located within our Class A Recycled Water Network.
